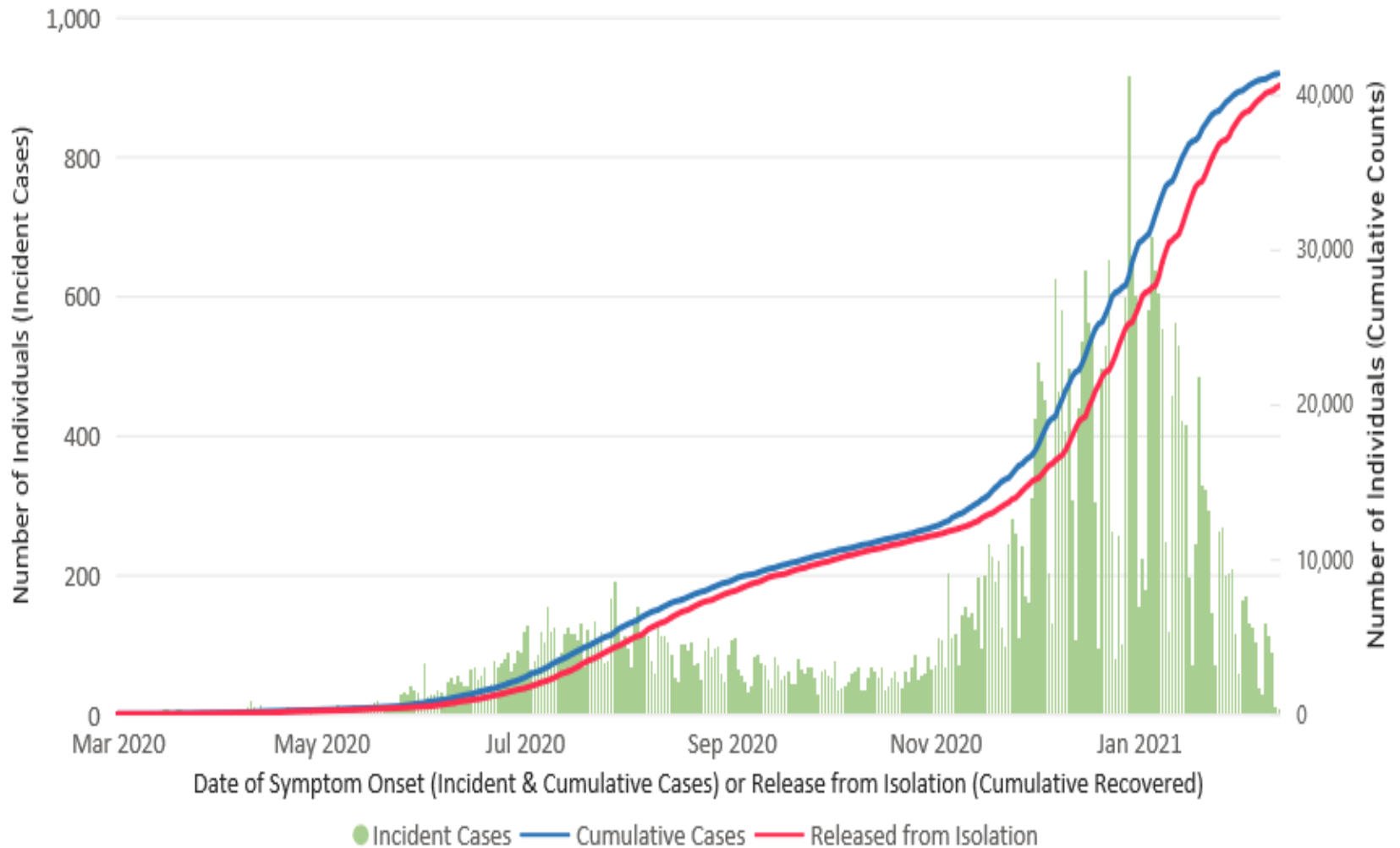

COVID-19 Among Monterey County Residents

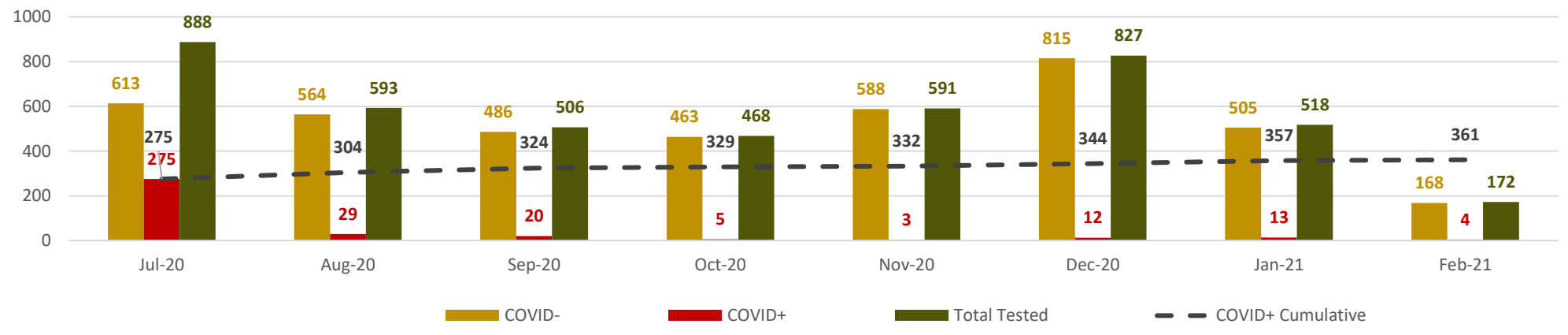

- January 25, 2021 – Regional Stay At Home Order ends. Monterey County returns to the purple tier. [More Information](#)
- January 13, 2021 – Governor Newsom announced the state is prioritizing individuals 65 and older to receive the vaccine.
- January 8, 2021- Monterey County remains under the State Regional Stay at Home Order. [More information](#)
- December 17, 2020 – First COVID-19 vaccines in Monterey County administered.
- December 13, 2020 – Health Officer State Order takes effect at 10:00 p.m. and will continue until 6:00 a.m. January 11, 2021.
- December 9, 2020 – [Health Officer Stay At Home Order](#) Issued.
- November 19, 2020 – State issues limited Stay at Home Order to slow spread of COVID-19. [More Information](#)
- November 4, 2020 – Monterey County’s Tier Adjustment Request Denied. [More information](#).
- October 18, 2020 – Coleman Fire starts north of Fort Hunter Liggett and near the Dolan Fire. Evacuation orders and warnings issued to the surrounding communities.
- September 5, 2020 – Carmel Fire and River Fire 100% Containment.
- August 28, 2020 – California has a new blueprint for reducing COVID-19 in the state with revised criteria for

loosening and tightening restrictions on activities. Find out how businesses and activities can open in counties statewide beginning on August 31.

- August 18, 2020 – Carmel Fire and Dolan Fire start.
- August 18, 2020 – Monterey County Board of Supervisors ratified a proclamation of the existence of a local emergency due to the River Fire. Fire at 10% containment.
- August 17, 2020 – Governor Gavin Newsom secured a Fire Management Assistance Grant (FMAG) from the Federal Emergency Management Agency (FEMA) to help ensure the availability of vital resources to suppress the River Fire burning in Monterey County. [More information](#).
- August 17, 2020 – Evacuation warnings issued to the surrounding communities. Evacuation Center at Buena Vista Middle School and Carmel Valley Library closed. Evacuation Center at Toro Park School Opens.
- August 16, 2020 – Evacuation Centers opens at Carmel Valley Library and Buena Vista Middle School.
- August 16, 2020 – River Fire starts off Pine Canyon southeast of Salinas. Evacuation orders and warnings issued to the surrounding communities.
- July 13, 2020 - Governor expands the closure of indoor operations in Monterey County. ALL counties must close indoor operations in these sectors: Dine-in Restaurants (indoor); Wineries and Tasting Rooms (indoor); Movie Theater (indoor); Family Entertainment Centers (indoor); Zoos and Museums (indoor); Cardrooms (indoor); Closure of all brewpubs, breweries, bars, and pubs (indoor and outdoor).
