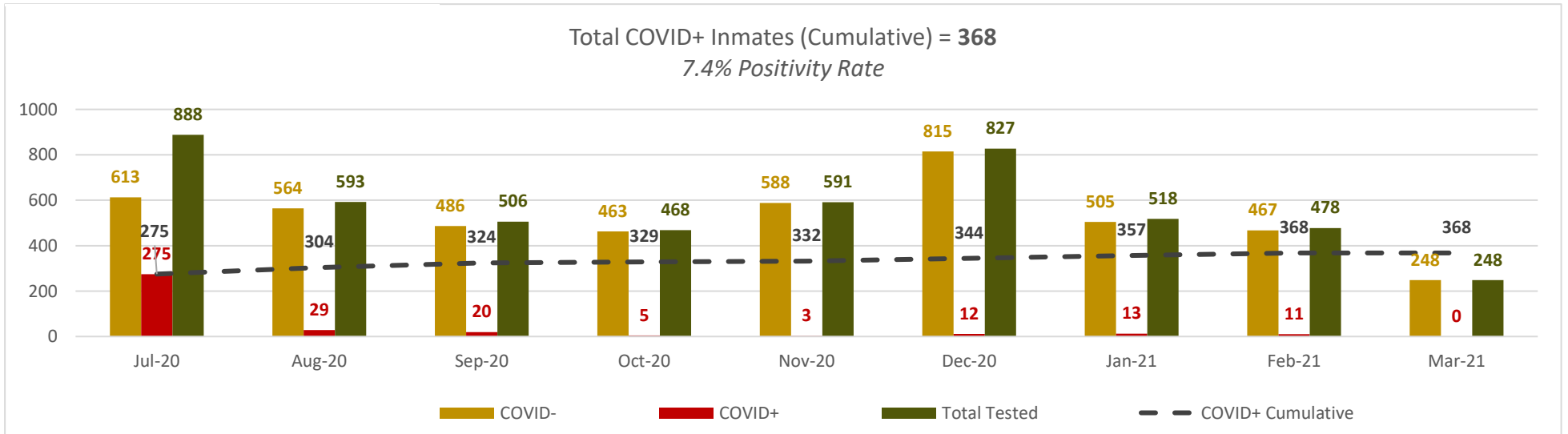

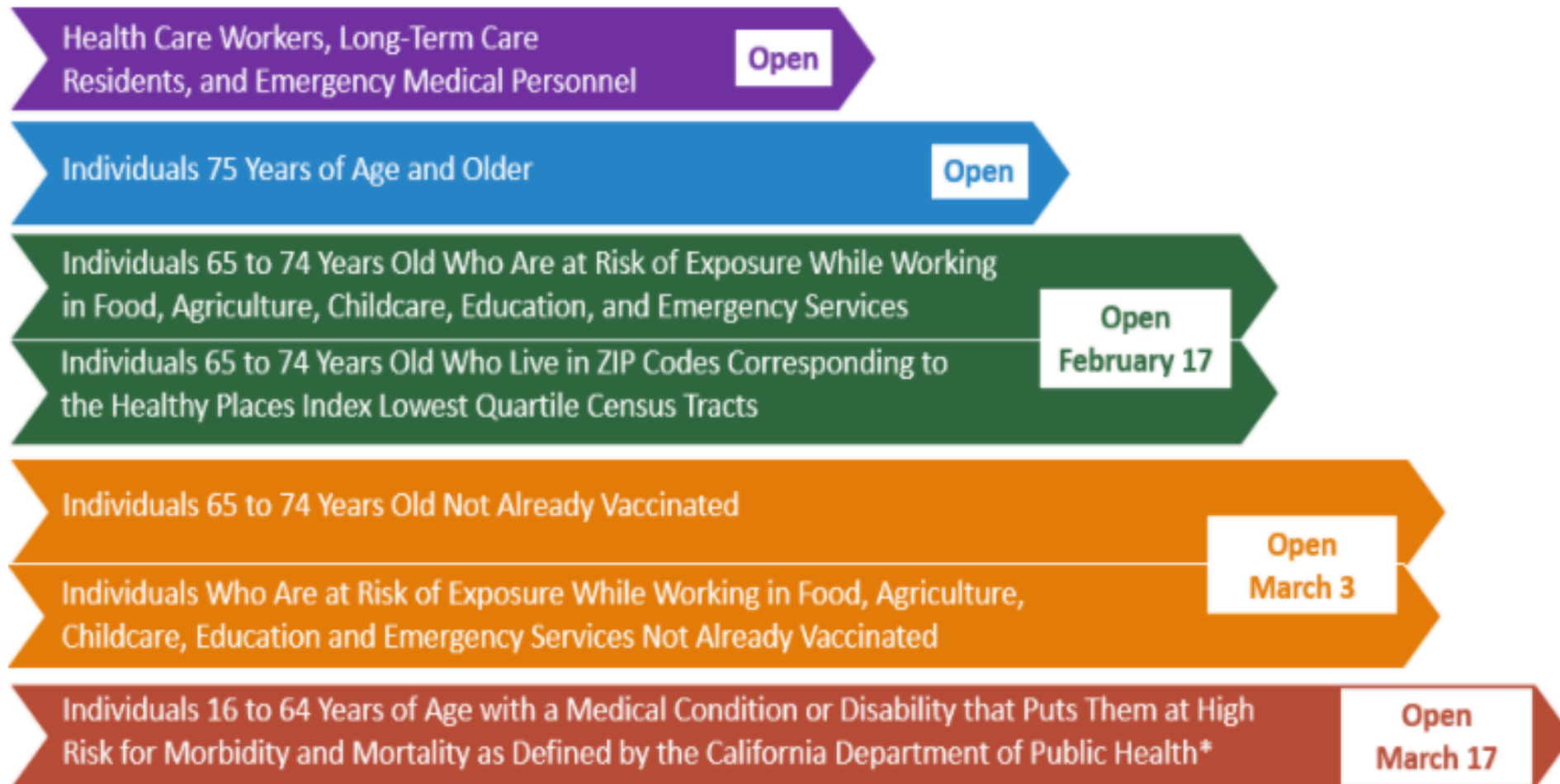


Who Is Eligible Now

Based on State guidance and local considerations, at this time the following Monterey County residents are eligible to receive COVID-19 vaccine:

- Health care workers, long-term care residents, and emergency services personnel
- Residents 65 years and older
- All residents who are at risk of exposure while working in [food, agriculture, childcare, education, and emergency services](#).

- ✓ Persons ages 16 - 64 with a medical condition or disability that puts them at high risk for morbidity and mortality as defined by the California Department of Public Health.

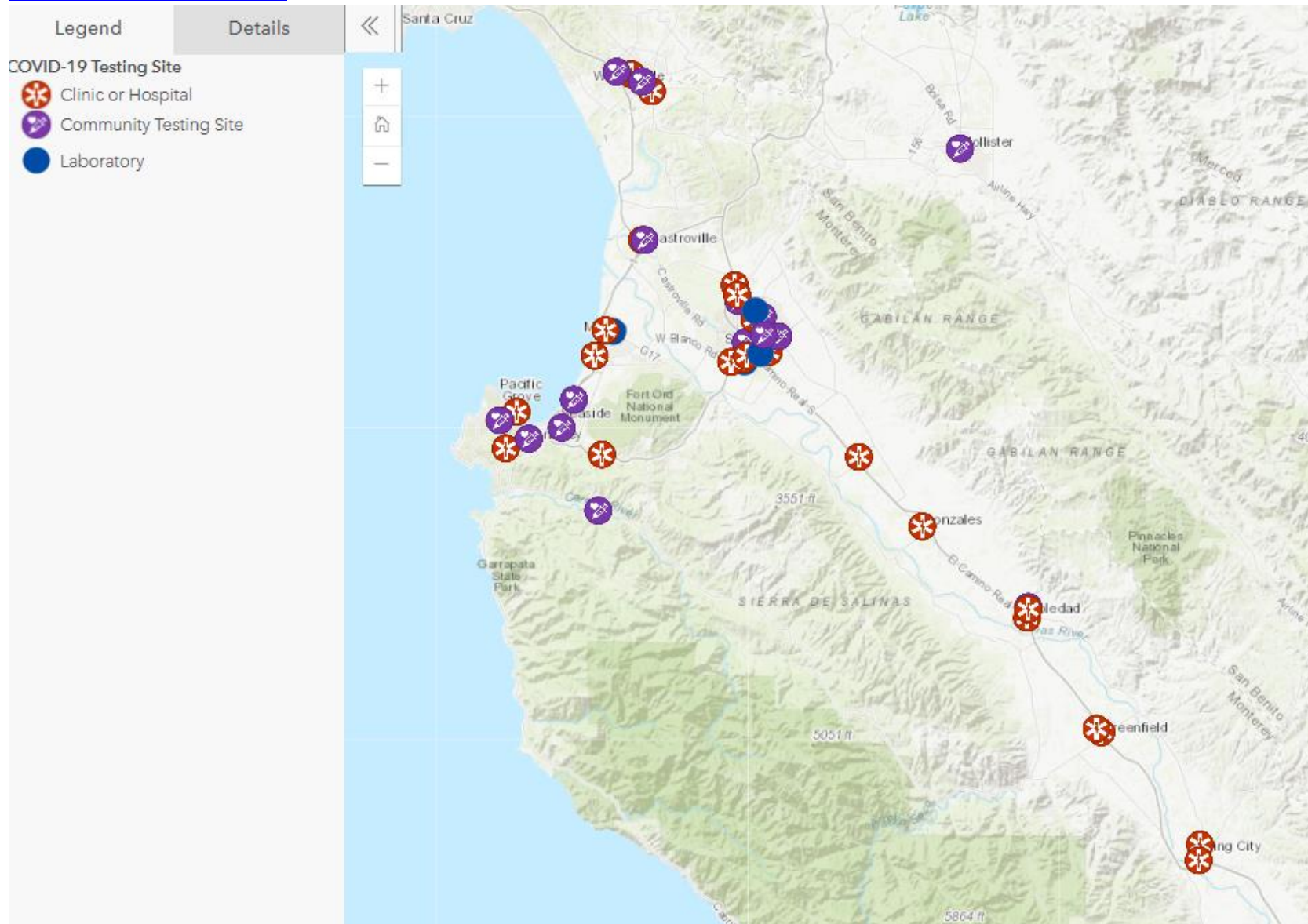

- March 16, 2021-Monterey County has met the requirements to move into the Red Tier of the Blueprints for a Safer Economy. The Monterey County Health Officer announced today that the County will continue to align with the State's framework and allow activities open in Red Tier counties to resume, effective March 17th. - March 13, 2021-Monterey County State Supported COVID-19 Testing Site to Change Days Open. Thursday March 18th the State supported COVID-19 testing sites in Castroville, Salinas, Seaside and Soledad will be open from 8 am to 8 pm, Thursday through Monday. Due to this change all four sites will be closed on Tuesday March 16th and Wednesday March 17th. [More information](#)
- March 5, 2021-Monterey County continues to receive and distribute COVID-19 vaccine throughout the county. On Tuesday, Monterey County Health Officer Dr. Edward Moreno updated the Board of Supervisors regarding the doses of COVID-19 allocated, received and administered to residents.

- August 28, 2020 – California has a new blueprint for reducing COVID-19 in the state with revised criteria for loosening and tightening restrictions on activities. Find out how businesses and activities can open in counties statewide beginning on August 31.
- August 18, 2020 – Carmel Fire and Dolan Fire start.
- August 18, 2020 – Monterey County Board of Supervisors ratified a proclamation of the existence of a local emergency due to the River Fire. Fire at 10% containment.

- August 17, 2020 – Governor Gavin Newsom secured a Fire Management Assistance Grant (FMAG) from the Federal Emergency Management Agency (FEMA) to help ensure the availability of vital resources to suppress the River Fire burning in Monterey County. [More information.](#)

- August 16, 2020 – River Fire starts of off Pine Canyon southeast of Salinas. Evacuation orders and warnings issued to the surrounding communities.

ALL counties must close indoor operations in these sectors: Dine-in Restaurants (indoor); Wineries and Tasting Rooms (indoor); Movie Theater (indoor); Family Entertainment Centers (indoor); Zoos and Museums (indoor); Cardrooms (indoor); Closure of all brewpubs, breweries, bars, and pubs (indoor and outdoor).
